#### 2a Land trust panel

There has been a lot of talk recently about land trusts. Land trusts can be used to preserve our non-profit housing co-ops and to leverage our assets to build more co-ops. CHFT has been involved in land trusts since the 1980's. We currently lease land to 31 housing co-ops. Find out about the history of land trusts in the GTA, the status of current land trusts and the future of land trusts in this area.
