

Woodsworth By-Laws and Policies on the Co-op Website

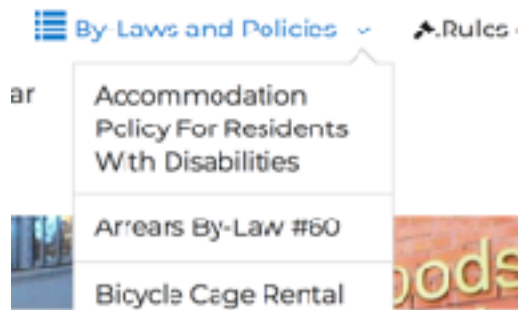
The Woodsworth website has all the co-op bylaws and policies. Our website - www.woodsworthcoop.ca.

Want to know about the bicycle cage, or booking the penthouse, or co-op spending policy, or accommodation for disabilities? It is all there! At least you can use them as a starting point.

All bylaws on the website have been approved by a 2/3 majority at a GMM. Additionally all policy documents approved by a simple majority at a GMM are on the website.

Three main ways to find them on www.woodsworthcoop.ca

1. On a computer, roll your mouse over By-Laws and Policies on the horizontal navigation bar on the website to get a dropdown A-Z menu of bylaws and policies - then click on the by-law or policy you want to open.



On a cellphone, click on Menu to see the items in the navigation bar in a list. On an iPad, turn your device landscape style (sideways) to see the regular computer view.

2. Click on the By-Laws and Policies menu item on the navigation bar (as above) for the by-laws and policies. By-laws are ordered by number and policies alphabetically. It brings you to this page:

3. Use the quick link By-Laws & Policies on the right sidebar to see them grouped in various ways:



a) Grouped by topic – by-laws and policies are grouped by three broad topics: organizational, operational and community.

b) By-laws in number order and policies are listed alphabetically. Only main by-laws are listed. Amendments have been incorporated into the main bylaw. For full details of amendments to individual by-laws, see the by-law history featured at the beginning or end of individual by-laws, i.e. in “complete list of by-law numbers” (c)

c) Complete list of by-law numbers, including rescinded by-laws and amendments. Use this list to assign the next available number to a by-law or by-law amendment. Archival interest.

All links pull up the full text of the approved in-effect by-law or policy.
